Minutes of Virtual Meeting of the above Council
Held on Wednesday 16th December 2020

1. **Apologies:** J.G. Parkin (Vice Chairman), Ms R. Spalding,
2. **Declaration of Interest** – if a member is present at a meeting of the authority, and they have a disclosable pecuniary in any matter to be considered or being considered at the meeting, they cannot take part in any discussion of the matter at the meeting or vote on it. They should disclose the interest to the meeting and follow the Council's Code of Conduct.
3. **Minutes** of Parish Council held 14th October 2020 were confirmed as a true and correct record on the prop., of P. Schofield, sec., E. Forshaw
4. **Matters arising** from last minutes:-
 - a. Extra Litter Bin in the Village – Woodcott Hill Lane and possibly Sheppenhall Lane/Junction A530. Clerk reported he has a quote of £386.40 + VAT per bin. Agreed to discuss further with R. Hibbert and see if any NNP budget would be available.
 - b. Village Notice Board – await quotes from R. Hibbert
 - c. Phone Box – need to decide what is the best option for this – painting a priority. Again need to look if any NNP budget available. Suggestion to replace notice board by using the kiosk to be considered.

Items 4/A/B/C have been deferred until NNP Financial Balances are concluded

- d. **Poppy Wreaths**, reported that J. Batho attended the Wrenbury Service with J. Barker doing likewise at Aston.

5. Highway matters:

a. Report as follows from R. Hibbert:-

I want to start with a sincere thank you to Rachel for arranging the meeting and for arriving despite the weather! Rachel - I don't have Sean's email address - would you please pass on my thanks for his time on the Parish's behalf?

We met Sean from Cheshire highways and has an excellent debate focused upon the risk associated with the crossroads on the A530, Sheppenhall Lane and Wrenbury Road. The traffic served us well with numerous examples of HGV scale, volume of A530 and crossing traffic, with numerous examples of how aggressive turning HGV's are to the surface area. Equally it served to demonstrate how exposed one can feel standing at the crossroads.

Conversation followed three subject areas;

- 1 Maintenance
- 2 Safety improvement
- 3 Condition

Maintenance focussed upon hedge rows and signs. Both can be improved. For properties where hedges are growing across boundary lines and impairing clear sight for motorists as well as creating less space for pedestrians, Sean proposed the normal process of request, warning then direct action. I proposed we (the Parish) make the first step asking the relevant property owner to cut back - or assisting as we have volunteers who can do so. Any failure can be followed up by Cheshire Highways direct request.

Safety focussed upon lines in the first instance. Clearly condition is poor and warning value very low (give way lines etc.). Sean offered a practical solution whereby reflective cats eyes can be installed - coloured - making the

junction clear in all conditions. Second he proposed improvement to the signs on the junction and finally, further management of hedgerows and banks.

Condition - the road surface will need improvement to accommodate the changes above and also to eliminate the flooding that is evident.

All of the above needs a) a plan b) approval c) funding. Having written that, probably in reverse order! Funds are available, the trick is to get them assigned. Here I see Rachel as our best advisor and sponsor - hopefully we can secure action in the near future.

Overall a very good meeting despite the conditions. I hope we can see positive improvements soon.

b. Road Closure

CHESHIRE EAST BOROUGH COUNCIL - NOTICE OF TEMPORARY ROAD CLOSURE
S14 (2) ROAD TRAFFIC REGULATION ACT 1984

NOTICE IS HEREBY GIVEN that the Cheshire East Borough Council in exercise of its powers under Section 14 (2) of the Road Traffic Regulation Act 1984 and of all other enabling powers issues this notice temporarily to prohibit traffic in the following length of road:-

Dodds Green Lane, Audlem Ward, Nantwich, SY13 4 from the junction with Whitchurch Road to the junction with Salesbrook Lane.

The closure is necessary to enable Cheshire East Highways to carry out jetting works.

AND

Dodds Green Lane, Audlem Ward, Nantwich, SY13 4 from the junction with Whitchurch Road to outside Blue Bache Farm.

The alternative route will be via the following streets: - Whitchurch Road, Dodds Green Lane

The closure is necessary to enable BT to carry out cabling works.

It is anticipated that the works will take place on the following date(s): Monday 8th February 2021 to Tuesday 9th February 2021.

- c. E. Forshaw reports:- large pothole in the centre of Wrenbury Road Aston, at the junction of Wrenbury Road and Sandy Lane. I have reported it the Cheshire East Highways, Ref 3412263.
R. Hibbert reported that the site had been inspected today by CE Highways.
- d. Flood on Sheppenhall Lane outside a bungalow on the righthand side, just before the turning on the left to Sheppenhall Grove. It appears every time it rains heavily in the winter, floods the verge, hedge and extends part way up the drive. The lady who lives there, is 95 and no longer drives. The flood is often too deep for her to wade through even her wellies, effectively trapping her in her property. Clerk to report to Cheshire East as a matter of urgency, highlighting the Isolation of the resident and CEC responsibility for caring for the vulnerable
Other floods in Sheppenhall Lane seem to be improved as does the centre of the village. However very bad flooding too in Wrenbury Road by The Ponderosa and Plantation.
- e. Footpath on Junction of Sandy Lane and Wrenbury Roar is in a terrible condition. CEC are committed to walking for residents but terrible maintenance record.

I am writing to confirm arrangements about the above new lunch club which ADCA aims to start in early January 2021 each Monday between 11.30am – 2 pm. This new club is funded through a Covid Recovery Grant from Cheshire East Council. The start has been delayed because of the second lockdown. We are now working on a publicity leaflet which we will send to you shortly for circulation locally.

We are also working in partnership with Wrenbury Together and will be providing transport via volunteer drivers and the local Wheelybus. If you know of any local people who would wish to volunteer as drivers, please let us know on the above contact details.

The lunch club will be Covid-Secure and will provide for 9 people each week. We aim to provide attendance each fortnight for up to 18 isolated older people who may live alone and need company and support. Members will be asked for a £10 contribution for what will be a hot two course meal prepared by one of our paid cooks with coffee/tea on arrival.

We are now looking for referrals of people who may want to come along for what will be a booked service. Please let us know of anyone who you think may be interested, with their permission, on the above phone number. Our Coordinator, Tracey Humphries, will then follow up people with a visit or phone call

As discussed, we have funding for up to 6 months from Cheshire East Council but will be looking for further funding into the future if the club is a success. Could we ask if your Parish Council would consider a grant towards the running of the club during the financial year from April 2021.

We will be also looking to undertake charitable fund raising in partnership with the Methodist Chapel and Wrenbury Together.

After reviewing the application it was agreed on the prop., C. Britton, sec., P. Schofield, to offer No Representation.

The Revised Publication Draft Site Allocations and Development Policies Document (SADPD) includes non-strategic planning policies and site allocations. It has been prepared to support the strategic policies of the Local Plan Strategy. Following the previous consultation in 2019, the draft SADPD has been amended and the council has now published the Revised Publication Draft SADPD to invite further representations before it is submitted for examination by a planning inspector. Full details of the consultation are set out in the updated 'Statement of the Representations Procedure' which is also attached to this email. The deadline for representations is now 5:00pm on Wednesday 23 December.

c. **Station Yard, Wrenbury – update on application for concrete works.** On the prop., J. Batho, sec., R. Hibbert, Nigel Spicer was invited to outline latest situation, as follows :-

- a group has been formed to liaise a joint and concerted approach to CEC
- the MP has been contacted requested his support
- request that a full use of all resources is used when looking at the application
- 150 objections to date
- CEC Planning Officer has been very helpful in guidance in relation to the application, and a good relationship has been established.
- Work has been completed on the project prior to the application being considered, and enforcement re this matter is of great concern. Wrenbury Parish Council (in their Parish) have raised a complaint that no enforcement has to date been issued.
- No contamination or environmental reports have been submitted.
- Highways is a major concern. Meeting with CEC Officer highlighting these concerns and especially the 24 vehicle limit. When over 100 vehicle movements are often recorded in one day.
- Further issues of vehicles reversing onto the highway was highlighted and reported to Police.
- Road is in a very bad state of repair and needs to be dealt with separate to the application.
- Discussions with Network Rail have taken place.
- Decision by the Case Officer likely in early January and subject to Committee on 4th February.

Next steps:-

- all comments should be directed through the formed group
- Group would like to ensure the continued support of the Parish Council
- Collection of data in relation to vehicle movements and state of the road a priority.

Thanks recorded to Councillor Bailey who has given great help and support in relation to the matter.

IV. **Neighbourhood Plan update:-** R. Hibbert reported:-

- Teamed with other parish councils re Highway matters. This will enable issues to be shared as one.
